LOWERING COSTS

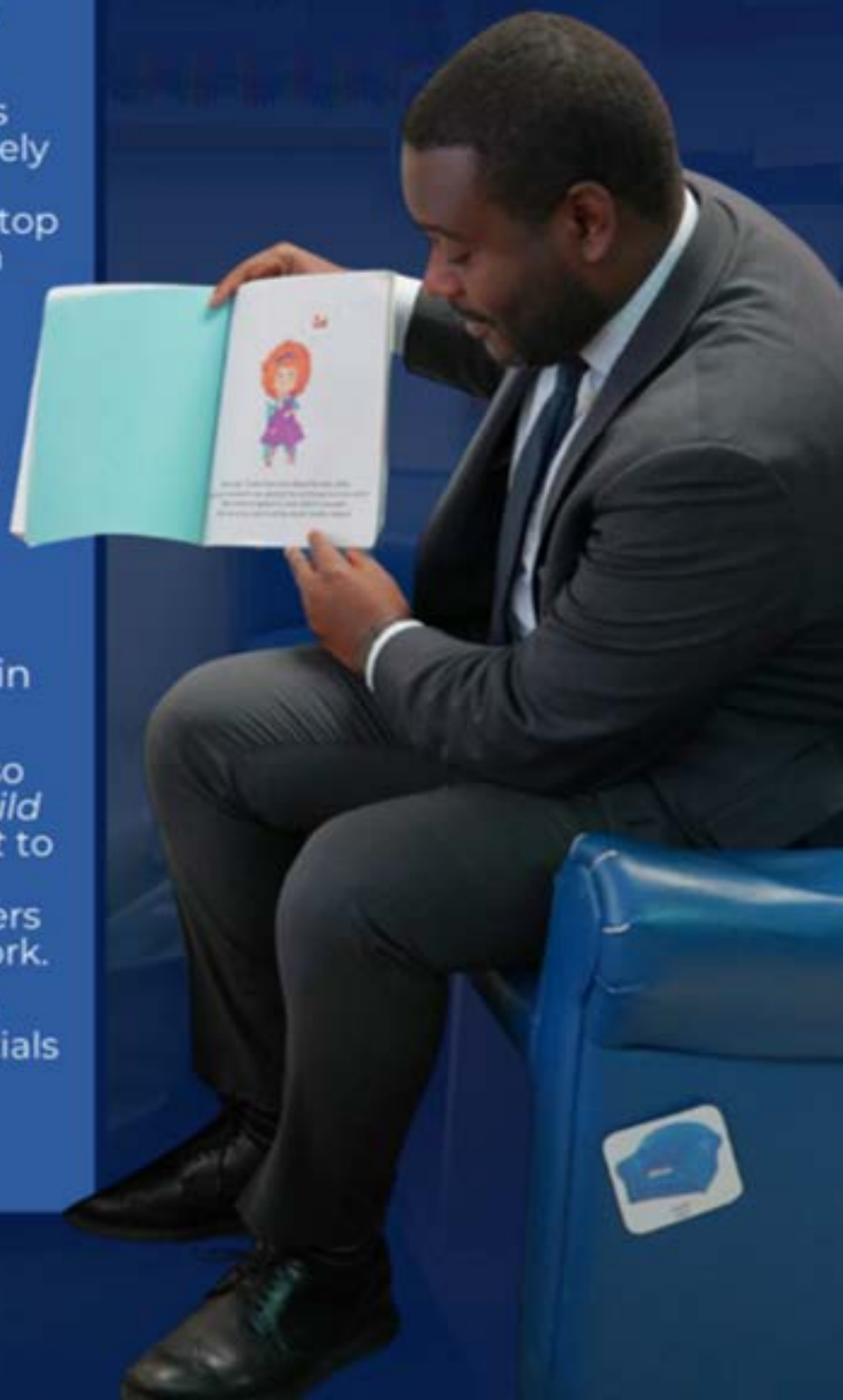
Lowering costs for hardworking Rhode Islanders is one of my main priorities in Congress.
